## Resolution #2: Daycare Advocacy among Northwestern Minnesota Synod Churches

## Submitted by the Roseau Conference

- 1 WHEREAS, the Evangelical Lutheran Church's Social Statement on Economic Life stresses that
- 2 our church promotes "sufficient, sustainable livelihood for all"; and
- 3 WHEREAS the Northwestern Minnesota Synod has a heart for children, youth and the homes
- 4 that nurture them:<sup>2</sup>
- 5 WHEREAS, northwestern Minnesota faces a daycare capacity shortfall of 39%, or 2,717
- 6 children;<sup>3</sup> and
- 7 WHEREAS, west central Minnesota faces a daycare capacity shortfall of 26%, or 2,476
- 8 children<sup>4</sup>; and
- 9 WHEREAS, there are twenty-five census tracts in our Synod that are considered "childcare
- 10 deserts"<sup>5</sup>; and
- 11 WHEREAS, the typical cost for childcare averages between 10% to 17% of the median
- 12 household income of a family<sup>6</sup>; and
- WHEREAS, the ripple effects of inaccessible and unaffordable daycare strains young families'
- work, home life, and finances within our communities and our churches; and
- WHEREAS, a number of congregations in our Synod<sup>7</sup> have opened their church spaces to
- 16 daycare centers or preschools; and
- 17 WHEREAS other congregations in our synod have unused or under-used spaces in their church
- buildings that could be used to provide childcare or preschool opportunities; therefore be it
- 19 RESOLVED, that the Northwestern Minnesota Synod, in Assembly, encourage the
- 20 congregations within this Synod to work toward local solutions to the daycare crisis within their
- 21 communities; and be it further
- 22 RESOLVED, that the Synod Council be directed to convene a gathering of representatives of
- congregations of the synod to explore ways to advocate for public policy positions aimed at
- 24 finding practical solutions for the childcare crisis on the territory of the synod.
