

Dear First Lutheran Friends,

Thank you for a pivotal year in First Lutheran's history. I realize there have been way too many interim pastors through your doors in the last six years and that Pastor Gretchen's leaving was abrupt for some people. Covid was hard on pastors and the card shower and generous gift of a computer was a way to say goodbye in a way she chose. Together, in 2022, we lived in God's presence, reflected God's grace, and lived out generosity to one another near and far.



The 150th Celebration of Joy echoed throughout the entire year. We acknowledged, gave thanks for 150 years of ministry and now embark faithfully on 150 more. We continuing to follow Jesus, deepening our commitment to prayer, and clarifying First Lutheran's vision God is calling us to throughout the congregation, community, country, and world. As your interim pastor, I have noticed that when a need arises, FLC responds generously.

- Fill the Cup giving \$6,000 that watch matched to the Lutheran Disaster Response that was matched and \$4,000 to local charities.
- Relay for Life honoring Karen Lundstrom that raised over \$5,000 for Lake Region Cancer Center
- Honoring Steve Hosch and Pastor David Strom at their retirements (even with Packers colors!)
- Harvest Dinner serving 330 in person and giving 200 meals to Salvation Army for the first time in 3 years
- Volunteer Custodians giving their time while we found the right person (currently happening).
- Honoring our promise to our partnership with the NWMN Synod of \$18,000 of which 50% goes back to congregations.
- Quilts and school kits donated through Lutheran World Relief which means the difference between a child attending school or not attending school.

Cookie bakers and deliverers to over 50 people in a snowstorm, funeral servers creating space for family and friends during a time of grief, dinner church that feeds the soul, Palm Sunday Brunch, Rally picnic, Senior Sunday Picnic, Generosity Sunday Potluck, OWLS gatherings, Archives Committee weekly meetings, Organ Dedication Concert with Daniel Aune, weekly confirmation, people returning to worship, and more!

All of this happens, not because of a pastor, but because YOU are involved and invested in the mission and ministry in this place. People are at a church much longer than any pastor will be. Your leadership, compassion, presence all "make God glad" (Psalm 21:6). (It makes your interim pastor glad, too!) It is a sign of health when we come together, work together, give together, and welcome others together in the name of Jesus our Savior. It isn't about any one of us, it is about being called together as a community of believers in Jesus' name and responding to God's call in this particular time and place.

This upcoming year together, we will deeply listen to what God's vision is for First Lutheran, form and call committee, and prepare to welcome your next senior pastor. We have gifted leaders serving on church council and on the transition team, AND will need your voice, too. Your presence makes all the difference at FLC.

May God's generosity and presence flow through us as we begin this new year. May we learn that life through God's eyes overflows with meaning, truth, and love. May we have our ears and eyes opened by the One who brings eternal life, our Savior, Jesus Christ.

The past year has provided a shift from distancing to connecting. We went back to in-person Sunday School and have been able to hold FLY at First Lutheran on the days when the weather is not favorable. Children and families have found their way back and apart of the First Lutheran community along with we have welcomed many new families. Sunday school/Butterflies attendance has increased by 10-15 children this school year with averaging 30 children a Sunday, and FLY K-6 has increased by 2 children this year averaging 19 children on Wednesdays.

MINISTRIES

This year our goals were: 1.) Building a foundation to help them live in God's way 2.) Discover that the Bible matters 3.) Connection with each other 4.) We are part of a community.

<u>FLY K-6</u>: FLY is a Wednesday after school program from 3:30-4:30 for ages Kindergarten through 6th grade. It is a time to worship and learn about Jesus through Bible stories, games, and activities. It is also a time to build relationships within our church community. Every couple of months, we have an event for youth (Kindergarten through 6th) that brings us together through different activities and projects.

<u>Sunday School</u>: During the 2021-2022 and 2022-2023 school year, we are using the *DIG-IN* curriculum. Our inperson classes are grouped into four groups: Butterflies (ages 0-3 years), Preschool-Kindergarten, 1st-3rd grade, and 4th-6th grade. Each Sunday the lesson includes a story from either the Old or New Testament that teaches one of the foundations of faith. There are low and high energy games and a craft to reinforce the objective of the lesson along with other activities for a deeper understanding. For individuals that are not able to attend in-person an at-home lesson is send via text message which includes the story with activity along with a short video and discussion. Each family receives a take home summary of the Bible Story along with the lesson's objective with some activities or things to talk about at home during the week. This is designed to help empower parents in both their children's faith journey and their own.

As you probably all know, this year marks the 150th Anniversary of the founding of our congregation. That means 150 years of Discipleship to our Lord and 150 years of service to Fergus Falls and beyond. To celebrate such a momentous occasion, this year's Generosity Sunday was spread out over three weeks for us to celebrate the Joy of Giving. Members of our committee were also able to participate, along with a few other members of our church, in a seminar, *Cultivating Generous Congregations*. This was, among other things, an opportunity for us to meet members of other ELCA congregations, and to share with each other inspirational stories about the importance of generosity. Lastly, we closed out the year strong by providing 31 Christmas food baskets for families in need within the community (8 more than last year) and by exceeding the \$75,000 goal for our Wrap it Up campaign by \$7,000, for a total of \$82,000 raised! Hallelujah!

PERSONNEL COMMITTEE

2022 was a challenging year for the personnel committee.

We started the year needing to fill two key position in our staff. Our senior pastor (Pastor Gretchen Enoch) resigned in December 2021 and our full time office assistant/bookkeeper (Doreen Oliphant) resigned the next month. Our treasurer, Leonard Hatzenbuhler, with his extensive background in bookkeeping, agreed to help with the bookkeeping duties until a replacement was hired.

In late January 2022 we hired Pastor Tiffany Sundeen as our interim senior pastor. She accepted a two year contract which has added a lot of stability to our staff. Throughout 2022 Pastor Tiffany has demonstrated true leadership skills and presented a clear vision for our path forward as First Lutheran Church community.

Beginning in January 2023 a transition team will begin the process of identifying the needs of our congregation so a call committee can be formed by late spring. The call committee will begin the search for our next senior paster who we hope to have in place later this year.

Mary Johnson, a lifelong member of FLC joined the staff on June 1 as a part time office assistant/bookkeeper. Jennifer Hubrig became our office manager in September after Katie Shallue resigned. Jennifer had ten years of experience working at an ELCA church in St. Peter, MN so she was able to come right in and fill the position. She has been working part time for the past four months but will transition to full time in February.

We currently do not have a Youth and Family Director for grades 7-12 to complement the great job Kristy Wicklund does with our K-6th grad youth. We plan to define the Director of Faith Formation job description and post for that full time staff position by early spring. The intention would be to have the position filled by September 2023 when the next school year starts.

Our custodian of 35+ years (Steve Hosch) retired in July and we are working to fill this key staff position. We are currently relying on volunteers from the congregation to fill our custodial needs so if you can help us please contact the church office.

Pastor David Strom retired in September as our visitation pastor. He has been a great asset to our staff and we than him very much for his dedication. We appreciate that he will continue leading the men's bible study group. Pastor Kate Bruns recently accepted our offer to become visitation pastor. She started January 3. Her years of pastor experience and knowledge of our community will make her a great addition to our staff.

We continue to have a dedicated staff that meets the needs of our church — Organist, Keith Melberg; Senior Choir Director, Harriet Wicklund; Bell Choir Director, Linda Mellon; and Praise Band Director, Anne Taylor. We appreciate all they do to make FLC our "home". Each week our church needs many volunteers (greeters, ushers, communion assistants, lector, acolytes, sound technicians, altar guild, and coffee servers). Your willingness to fill these spots is most appreciated.

I also want to thank Joe Ellig for his many years of service to the personnel committee. He retired from the committee on 12/31/2022.

The current members of the personnel committee are: Kim Ward, Andrea Loomer, Al Jenson, and Bob Ronning. I appreciate their service ad dedication to this committee and look forward to working with them in 2023.

Happy 150th anniversary, First Lutheran Church! We can remember this most recent year along with 150 years that brought us to where we are with JOY!

The doors of First Lutheran Church are wide open, allowing us to worship together! Attendance in worship continues to be considerably less than it was prior to the onset of the recent pandemic. Along with attendance being down, the number of people willing to volunteer for roles in worship is also down. "Who will ring the bell? Who will serve as usher, communion assistant, lector, cantor...? This year, we have worked and continue to work to re-establish these roles which in the past were more easily filled.

Our worship committee's assignment is "to foster the worship life of the congregation..."

"Worship is the heart of congregational life, and our committee meets monthly to give careful consideration to providing an inviting and meaningful experience, with Jesus Christ at the center." Work this year has been focused on providing support in planning and preparing for the worship experiences of our congregation. We were excited to plan special music offerings through the celebration of our 150th anniversary.

Highlights of our committee's work in 2022 include:

FIRST LUTHERAN CHURCH CEMETERY

First Lutheran's two cemeteries are open to all First Lutheran members as well as people from other faiths and traditions. The largest cemetery, referred to as the North Cemetery is in Fergus Falls Township about three miles northwest of the church. The other cemetery, referred to as the South Cemetery is located in Dane Prairie Township approximately 2 1/2 miles southeast of the church. The committee's goal is to keep these areas well groomed, i.e.; grass mowed regularly, weed control, trees pruned, and removal of old flowers and ornaments and to keep driveways in good condition. Our main objective is to assist families in selecting a proper burial plot for their loved ones at the time of need. Another important task is to see that a written notice is sent to each family of their plot selection including the rules and regulations of the cemetery. All plot ownership records are available at the church. The committee also assists local funeral homes and monument companies in locating and marking grave plots when requested. Within the North Cemetery is a shelter in which a detailed directory is housed to assist families and other visitors in locating the resting place of their loved ones.

During the calendar year of 2022 there were a total of 9 burials in the North Cemetery and no burials in the South Cemetery. The committee continues to maintain both cemeteries to the highest standards so as to make them inviting to all who choose to visit their deceased loved ones.

Is This as Good as it Gets?

Beloved in Christ of the Northwestern Minnesota Synod,

In the 1997 movie by the same name, a mentally ill character played by Jack Nicholson, wonders aloud to a waiting room full of fellow sufferers, "Maybe this is as good as it gets." Over this last year, I've heard many of you lay and rostered leaders wonder the same thing about our life together as the church in this early part of the 21st century as we continue to deal with the lingering effects of the pandemic and the many years of gradual decline in church attendance leading up to it. Although this may not be everyone's reality, we all live among beloved neighbors for whom it is. For many of you, this means, among other things, that you are having to make some hard decisions at this year's annual meetings.

Paul's letters to the Christians in Corinth were written to people who never expected the church to amount to much of anything in this world, and Paul is encouraging them to be good with that. Then, 400 years later, things took an unexpected turn, and for the next 1,400 years or so, the church enjoyed a place of power and prestige in western society. That bygone era yielded mixed results for humankind, for the planet and for the Gospel. But having a big institution with lots of members enjoying great influence over the affairs of this world was never the point; it still isn't.

Consider that being a community of faith that feels its fragility and knows that its place in society is closer to the margins than it is to the center, is a better place from which to practice the way of Jesus – the way of love, service, and humility. There are two things that do not require slick, well-funded programming or big crowds of people, and they happen to be the two most important things: we can share the good news about Jesus Christ, and we can give ourselves, our time, and our possessions to love and serve the neighbors that God has placed among us.

"Will the people come back?" "Will our congregation survive another 5 or 10 years?" These are heartfelt questions that we ask because we cherish these congregations and what they've given us. But these are not Gospel questions. Some Gospel questions might be, "How can we use what we have to grow closer to Jesus?" "With whom can we share the good news, and how will we do it?" "Who needs our love and care, and how will we give it in a Christ-like spirit?" Focusing our life together on these questions costs us nothing – and everything. But what more could there for us be than this, for us who follow Jesus?

Beloved in Christ, thank you for your faithfulness in the Gospel. On behalf of our entire staff, we are grateful for you and for all that you do to share the love of Jesus Christ in the world.
