Every month, I brought a devotion to the people residing at Mill Street Residence and offered another devotion over the radio on "Morning Watch". I was privileged to preside at the funerals for Craig Alan Samp, Todd Douglas Kjellerup, LaVerne Marion Weinhandl, and shared with Pastor Tiffany the funeral service for Carl Prischman. I also presided at the burials for Ann Ness, Norman Lee Bailey, and Becky Weidl.

Assisting in worship services and singing in the choir have been part of my "want to" not "have to" choices, but I am also grateful for the opportunities given to me to preach on Sunday mornings and at Wednesday night Dinner Church. ## PRESIDENTS' REPORT

First of all, we would like to thank the members of First Lutheran Church for the opportunity to serve you as Council Co-Presidents. Our Sunday worship attendance continues to grow. It is wonderful to see long time members, returning members, new members, and visitors in our Sanctuary to hear the word of the Lord. The year 2023 has come to an end with First Lutheran Church seeing many positive accomplishments that cause us to look to a bright future.

Our staff has and continues to do great work in the day-to-day operations of the church with Pastor Tiffany leading the way. Many thanks to Pastor Tiffany and Pastor Kate for their theological guidance and their caring pastoral care. Jen Hubrig, Church Administrator and Mary Johnson, Office Assistant work to make sure everything flows smoothly which involves a lot of effort that is done behind the scenes.

Our Sunday School Program has grown greatly in 2023 under the direction of Kristy Wicklund, Director of Children's Ministry. In March 2023, a Transition Team was formed to gather information about the community outside of the church to aid the Call Committee in their work. The Committee members were Rick and Linda West (Co-chairs), Roy and Shelia Graham, George and Ann Mathison, Marlene Wilde, Leslie Flugstad, Missy Mattson, Jeani Trosvig and Kari Vaughn. Eleven agencies and businesses responded to the survey with responses to the following questions: 1) What are our community's greatest assets? 2) What are our community's greatest needs? and 3) How might these unmet needs be met? In July, a summary of the survey was presented to the congregation and passed on to the Call Committee for their use in the preparation of our Ministry Site Profile.

Our Call Committee has completed a congregation survey, completed the Ministry Site Profile work and is now receiving applications and reviewing senior pastor candidates.

Our Council Committee Chairs and committee members continue to do their good work. Please see their individual committee reports included in this Annual Report for details of their accomplishments. Some of our committees are looking for additional members to assist with their work. This is a great opportunity to be involved and get to know members of the congregation better through committee work.

Wednesday night Dinner Church is a relatively new event for us. It has been successful especially with the help of the Confirmation students and their families.

We want to also acknowledge all the volunteers who give their time and talents to our mission, both in our church and in our community.

In closing, we are incredibly grateful for the great teamwork that caused us to move forward and thanks to all for a positive and successful year. 1 Peter 4:10 "Each of you should use whatever gift you have received to serve others, as faithful stewards of God's grace in its various forms". We had 59 Kindergarten- 6<sup>th</sup> graders that attended Day Camp with Luther Crest and 20 children attended Butterflies VBS at First Lutheran Church. It has been amazing to watch these children grow at First Lutheran and to see relationships build between children, families, with God, and the church. A huge THANK YOU to our Children Ministry Volunteers that help make our Sunday, Wednesday, and VBS programs happen. #### PERSONNEL COMMITTEE

2023 was a rewarding year for the personnel committee. After filling our open office staff positions in 2022 (Jen Hubrig, Office Administrator and Mary Johnson, Bookkeeper/Administrative Assistant) we started 2023 with three main goals.

#### They were:

- 1. Find a custodian to replace long time employee Steve Hosch after his retirement in 2022.
- 2. Add a Visitation Pastor to the staff after Pastor David Strom's retirement in the fall of 2022.
- 3. Hire a Director of Youth and Family Ministry to meet the needs of our Junior and Senior high youth and the young families of our congregation.

#### **Custodian Position**

With the help of the executive committee, it was determined that going forward we would make the custodian position a part-time position rather than a full-time position with benefits etc. This decision helped us manage our overall expenses considering the other two staff positions we needed to fill. After several months of searching, we decided to hire a cleaning service rather than hiring a part-time staff member. In May of 2023 we contracted with Service Master and have been very satisfied with their services. We want to thank the many members of the congregation that filled the open custodian position between August of 2022 and May of 2023.

A special thank you and recognition should be given to Keary and Sue Toso for all the hours they volunteered. Keary and many others also spent many hours cleaning the "boiler room" and church basement, which was badly needed.

#### **Visitation Pastor**

Pastor Kate Bruns started as our new Visitation Pastor on Jan. 3rd of 2023. She agreed to work 20 hours a week calling on our members that are no longer able to make it to church or are living at our local care centers. Pastor Kate has served several congregations in the Fergus Falls area for many years, was well known by many of our members and still has a strong desire to continue serving a church community. She has developed a list of over 50 members that she visits regularly. Since joining our congregation she's also joined the adult choir and has actively helped Pastor Tiffany with Sunday services and most recently agreed to work 10 additional hours each week in her role as visitation pastor. We are very thankful for all that Pastor Kate does for First Lutheran!

#### Director of Youth and Family Ministry

Kristy Wicklund continues to do an outstanding job in her part-time role as Director of Children's Ministry (children ages birth - 6th grade) here at FLC. To continue our commitment to youth ages 7th through 12th grade it was determined we should post for the position of Director of Youth and Family Ministry. Fortunately, one of the members of our congregation had past experience working with youth and felt a call at this time in her life to devote the time and energy to our junior and senior high youth. Jen Enstad-Petersen started on July 1st, 2023. Our initial thoughts were that this position would be a full-time staff position but after discussing and defining her role it was decided that Jen would work 30 hours per week. Both Kristy and Jen welcome parents that can volunteer to help with youth activities and programs. We are all very excited at the progress Jen has made since July in creating a church "home space" for our older youth and for young families.

Currently FLC has no open staff positions but our two-year Interim Senior Pastor position that Pastor Tiffany Sundeen has been filling will soon come to a close. We have been so blessed by her leadership and enthusiasm. We have come a long way from the depths of COVID-19. Pastor Tiffany has been preparing the staff and the congregation for the transition that will surely take place in the coming months as we call a new senior pastor at First. Pastor Tiffany's leadership will be felt for many years to come. Thank You Pastor Tiffany.

As we start 2024 the personnel committee and the church leadership team will be working on our church sick leave policy to make sure we are in compliance with the new Mn. state law dealing with employee sick pay. A 3.25% C.O.L.A. (cost of living adjustment) was given to all staff for the 2024 calendar year, which was right in line with state and federal govt. guidelines and many local employers in Ottertail County.

I want to thank the current members of the personnel committee for their service to FLC and for their dedication to this committee and I look forward to working with them in 2024.

#### FINANCE COMMITTEE

The primary responsibility of the Finance Committee is to coordinate and supervise the financial activities of the congregation. This includes giving accurate reports and preparing a Ministry Spending Plan for the year.

The finance committee was re-energized with the introduction of our new trial governance model. New committee members were appointed, and we began meeting in June. We extensively reviewed each of the church's funds and began work on producing clear and accurate reports for the council and committees.

The previous years' Council entered into a contract to repair the large stained-glass window on the east side of the narthex. The work was to be completed in the Fall of 2023 and we were planning a campaign to fund these repairs. However, supply chain issues caused this project to be moved to the Spring of 2024.

We determined a need for and developed a Fundraising Policy & Procedure to help the church practice good stewardship, to act respectfully toward members of the congregation and others who are asked to support the church and its fundraiser, as well as supporting the goals of groups which participate in fundraising.

Suzanne Demuth and I had been working on getting the documentation needed from the IRS to request the Employee Retention Credit (ERC) for many months. In September we finally had all the information we needed, and Suzanne completed the paperwork requesting this credit. The amount is just under \$85,000. However, the IRS has put a hold on processing these requests and when they resume, processing times for these credits is six months or more.

The process for developing the Ministry Spending Plan for 2024 was extensive. We asked every committee to submit budget requests and Jen Hubrig met with each committee to show them their current expenses and to answer any questions about the financial practices of FLC. The Personnel Committee made a Cost-of-Living Adjustment recommendation to the Council and we reviewed every line item of the plan.

Thank you to all staff, volunteers, and members of First Lutheran Church for your faithful stewardship of God's abundance.

## FIRST LUTHERAN CHURCH CEMETERY

First Lutheran's two cemeteries are open to all First Lutheran members as well as people from other faiths and traditions. The largest cemetery, referred to as the North Cemetery is in Fergus Falls Township about three miles northwest of the church. The other cemetery, referred to as the South Cemetery is located in Dane Prairie Township approximately 21/2 miles southeast of the church. The committee's goal is to keep these areas well groomed, i.e., grass mowed regularly, weed control, trees pruned, and removal of old flowers and ornaments and to keep driveways in good condition. Our main objective is to assist families in selecting a proper burial plot for their loved ones at the time of need. Another important task is to see that a written notice is sent to each family of their plot selection including the rules and regulations of the cemetery. All plot ownership records are available at the church. The committee also assists local funeral homes and monument companies in locating and marking grave plots when requested. Within the North Cemetery is a shelter in which a detailed directory is housed to assist families and other visitors in locating the resting place of their loved ones.

During the calendar year of 2023 there were a total of 6 burials in the North Cemetery and 1 burial in the South Cemetery. The committee continues to maintain both cemeteries to the highest standards so as to make them inviting to all who choose to visit their deceased loved ones.

#### NORTHWESTERN MINNESOTA SYNOD



"Do not be afraid, Mary; you have found favor with God.

You will conceive and give birth to a son, and you are to call him Jesus." Luke 2:30-31

Dear Beloved in Christ of the Northwestern Minnesota Synod,

This message is written in the season of Advent, a season I have loved since I was old enough to know that there were seasons. There is something about this season's mix of melancholy and hope, darkness and light, that resonates with me. Children are central to the stories of Advent and Christmas — both in their preciousness and in their vulnerability. Every parent knows the agonizing mix of hope and fear that we carry for our children. As I write this, there is a devastating war happening in the land where the stories of our faith unfolded. And tragically, this war's devastating cost is landing mostly on children. "A voice is heard in Ramah, weeping and great mourning, Rachel weeping for her children...". (Matt 2:16). Join me in praying every day for a just peace in the lands of Israel and Palestine and for protection of the children.

As a parent and now grandparent, I know that the most desperate prayers we pray are for our children. When I visit congregation members and leaders across the synod, one deep question is always lurking: "What will our children's and grandchildren's experience of church be?" What I have learned is that making it about our kids means making it about faith in Jesus, plain and simple. We must give up needing our kids' experience of church to be like ours was, and instead pray for and work toward a church where children simply have a deep faith in Jesus Christ and a community of faith that loves them. It's back to basics! Back to basics often involves letting go of cherished traditions, buildings and ways of doing things that may have worked for us, but now only hinder us from focusing on growing our and our children's faith.

So, much of our work this last year has and will continue to focus on how to become a church where a child's faith can grow. This does not mean throwing programs and events at our kids, hoping something sticks. IT MEANS MAKING OUR LIFE TOGETHER ABOUT OUR FAITH IN JESUS and then generously, freely and often, sharing our faith with our children. Jesus-loving adults are the force that shapes the faith of children. This means freeing up communities to expend less energy on "keeping this thing going," and much more on hearing the gospel, praying, dwelling in God's word, serving the neighbor and seeking Jesus in our everyday life.

Hence, this year has been filled with hard and focused work of continuing to build out a robust network of support and accountability for lay ministers who serve in Word and Sacrament ministry under the mentorship of a seminary-trained, ordained pastor. Our process for vitality of smaller member congregations, "Rural Revival," has drawn us deeply into finding right-sized ways of providing word and sacrament ministry tailored to the unique needs of each community. While neither of these efforts look like "youth ministry," they really are because they free people to be more focused on the basics, more focused on following Jesus. ANY church that is focused on following Jesus is a church that is for the children.

So that is my simple appeal to you as you gather for your annual meetings this year. Let's make it all about being Jesus-followers sharing our faith with everyone, starting with our children.
